

Rules Regarding Access to Pool and SPA areas Gîtes in the La Réparade Estate

In order to guarantee maximum safety for everyone, to make your holiday pleasant and to keep the equipment in good working order, guests are kindly requested to comply with these rules regarding the pool and the spa and to commit to respecting safety and hygiene regulations in the interest of everyone.

The following points are to be observed and complied with:

Article 1 – Anyone who has not accepted said rules by way of signing the bottom of the copy provided by the owner is not permitted access to the pool or the spa area. It is obligatory that swimsuits be worn in the pool and the spa.

Article 2 – The pool is open to guests between 9.00am and 10.00pm, except in the case of force majeure (bad weather, cleaning, etc.)

Article 3 – The pool is a private pool and can be used only by the owners' family members and their friends and guests residing in the gîtes. The owners would like to remind pool and spa users that there are no lifeguards at the pool and spa and thus adults are responsible for ensuring safe practice.

Article 4 – Children under 16 are not permitted to access the pool and spa areas unless accompanied by a parent aged 16 or over.

They must be supervised by a responsible adult who knows how to swim (in order to avoid all risks of accidents, we request that young children are supervised in particular). Under no circumstances may children be left alone at the side of the pool. If applicable, when swimming, babies must have special swim diapers.

Article 5 – A maximum of 20 people are permitted to be in the swimming pool at the same time.

Article 6 – Pool users commit to :

- Go through the footbath and to take a shower before swimming and not to go swimming after having used sun cream or sun oil and to use only their own towels.
- Only wear sandals intended for such a use for accessing the pool (no normal shoes, no bare feet).
- Only bring drinks in plastic containers.
- Lock the access gate securely every time they enter or leave the pool.

Article 7 – It is forbidden:

- To go swimming at night.
- To remove the protective tarpaulin if this is in place, in this instance the pool is to be considered as closed.
- To throw or push anyone into the water.
- To use soap or any other similar product in the pool.
- To splash people who are in the pool or to remove water from the pool in any manner, through "dive bombing" for example.
- To scream or to organise violent games in the pool or next to the pool.
- To urinate in the water.

- To throw objects, stones or anything else in the water (any material which is damaged or destroyed shall be invoiced to SARL Gîtes de la Réparade – Chemin de la Réparade – 83670 Châteauevert

the person responsible).

- To run around the pool, to run on the edges of the pool and the grass when they are wet (risk of slipping and/or injury).
- To clutter up the pool with inflatables. Ball games are permitted as long as they are not disturbing anyone.
- It is strictly forbidden to access the plant room and to touch the electrical equipment.
- The use of rubber rings and other buoyancy aids are the responsibility of the guests.

The pool area is a place of calmness and relaxation, thank you for respecting other people who are around the pool and spa area.

Article 8 – All pool users must be covered by legal expenses liability insurance and recognise that the owners are relieved of all responsibility in terms of the supervision of anyone on the holiday.

Article 9 – In the case of repeated breaches of one of these articles, the owners can rescind their prior authorisation to use the pool and spa area without having to provide any compensation therefore.

Article 10 – The garden furniture which is provided around the pool is the responsibility of the users, who must take all measures and precautions in order to ensure it remains in proper working order.

Article 11 – Use of the spa

- The spa can be used by adults or children accompanied by a responsible adult.
- Use of the spa is authorised between 9.00am and 10.00pm.
- Users must under no circumstances modify the temperature controls in the spa.
- The protective cover must be replaced after each use. This is to prevent accidents and to maintain the water temperature.
- The guests commit to using their own personal towels when using the spa.
- Violent games and jets of water are formally prohibited in the spa.

In order to allow all the guests to benefit from using the spa each session is limited to 20 minutes. This period of time also corresponds to the usage limit advised by relaxation specialists.

Article 12 – Pets:

Pets, even those on a lead, are forbidden in the areas surrounding the pool and the spa.
